

**ATTENTION ALL TAXPAYERS  
NOTICE OF PROPERTY TAX****PROPERTY TAXES DUE JULY 4, 2016**

The 2016 property tax notices have now been mailed. If you have not received your tax notice, please contact the Financial Services Department at White Rock City Hall at 604.541.2280 or 604.541.2107 as soon as possible.

If you are a **new homeowner**, please note that you are responsible for payment of 2016 property taxes by the due date to avoid penalty.

All property owners are responsible for payment of property taxes regardless of whether a tax notice is received or not.

**How to Pay**

Property taxes and Home Owner Grant applications\* are due on or before Monday, July 4, 2016. Payments can be made in one of three ways:

**Through your bank**

Pay your taxes online or by phone using your financial institution's electronic bill payment system. To set up your payee, search for White Rock and select TAXES and enter our nine-digit property tax folio number (excluding decimal point) as your account number.

You can also pay in person at your branch. *\*Note: Most financial institutions no longer accept Home Owner Grant applications.*

**By mail**

Mail early. Send a post-dated cheque and your completed Home Owner Grant application\* to City Hall by mail. All payments and grant applications must be received at City Hall by July 4, 2016 in order to avoid penalty. Mail lost or delayed by the post office will be subject to penalty.

**At City Hall**

Pay with cash, cheque or debit card during regular office hours (8:30 a.m. to 4:30 p.m. Monday to Friday) or use the convenient mail drop at the front entrance. Please note that City Hall will be closed Friday, July 1, 2016.

**\*Save Time, Claim your Home Owner Grant Online**

You can claim your Home Owner Grant online through the City's website, [www.whiterockcity.ca/hog](http://www.whiterockcity.ca/hog). You will need your nine-digit property tax folio number and your access code from the shaded area on the top left of your tax notice. Note that Home Owner Grant applications are due on or before Monday, July 4, 2016 or will be subject to a late penalty.

**Late Payments**

A 5% penalty will be added to any 2016 property taxes remaining unpaid after July 4, 2016. A further 5% will be added to taxes unpaid after August 15, 2016. Unclaimed Home Owner Grants are considered unpaid taxes and also subject to penalty.

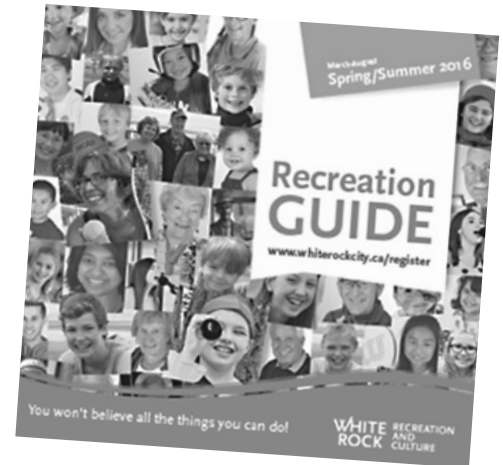

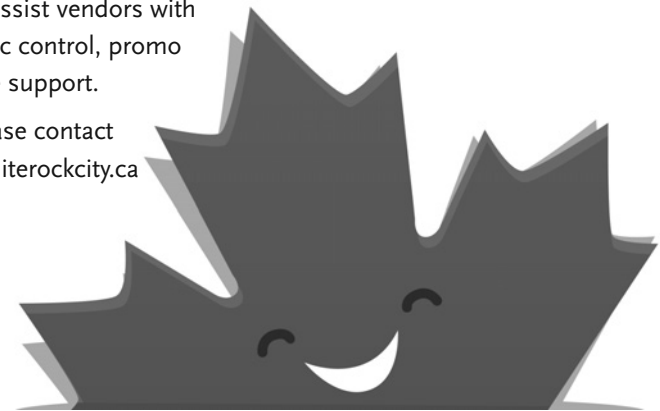
