

APPLICATION FOR APPOINTMENT TO THE BOARD OF VARIANCE

The purpose of this form is to provide information, which will assist Council in selecting individuals to serve on the Board of Variance. All applications will be considered in confidence. An interview may be held.

The Board of Variance is an independent decision-making board consisting of three volunteer members of the public who have been appointed by the City of White Rock Council to make decisions on:

- Relaxation of zoning regulations;
- Extension of non-conforming uses;
- Relaxation of servicing requirements;
- Reconstruction of a non-conforming building; and
- Relaxation of tree protection requirements.

Board of Variance Members must demonstrate:

- Residency in White Rock
- Objectivity and ability to avoid bias or the appearance of bias in actions and decisions;
- Ability to think independently and express opinions respectfully;
- Ability to collaborate and communicate effectively with colleagues;
- Ability to establish and maintain effective working relationships with City staff;
- Tact and diplomacy in dealing with members of the public and with sensitive or contentious issues; and
- Integrity and commitment identify conflicts of interest if they arise.
