The City of White Rock has processed your request for access to the following records pursuant to the *Freedom of Information and Protection of Privacy Act* (the "Act"):

- 1) *The total amount of compensation/allowance/severance/buy-out or other agreed upon remuneration package from White Rock that Dan Bottrill will be receiving as a direct result of the termination of his employment with the City of White Rock.*
- 2) *A copy of the final Agreement showing the terms, conditions and total amount of compensation/allowance/severance/buy-out or other agreed upon remuneration package from White Rock that Dan Bottrill will be receiving as a direct result of the termination of his employment with the City of White Rock.*

Access to the records you have requested is not available. The information is excepted from the disclosure requirements of the Act pursuant to settlement privilege at common law. Portions of the records are also excepted pursuant to section 22 of the Act.

Settlement privilege is a common law right that allows the parties of a litigious dispute to freely discuss and settle matters without concern that the content will be disclosed to their detriment following settlement. It is a right afforded to both parties in the dispute and the Office of the Information and Privacy Commissioner for British Columbia has recently held that settlement privilege can apply to settlement agreements between a public body and their employees (see: <https://www.oipc.bc.ca/orders/2377>).
