Please note the following definitions:

- **Family** means those who live at the same address; family members of all ages, including those related by blood, marriage/common-law or adoption. Same address includes separate living areas in one house (e.g., grandparents, siblings, or two (2) related families, each of whom may occupy one floor of a multi-unit house are considered one family).
- **Total Family Income** means total combined income, before taxes, by all family members 19 years and older in Canada and abroad, contributing to the household's income and expenses. This includes income from: employment of all types (full and part-time, reported or not reported) all investments, pensions, child support payments, rental revenues, funds in trust, disability benefits (taxable or not) and all other sources.
